I am pleased to transmit the attached **Restricted Disclosure** report detailing results of the vulnerability assessment and penetration testing evaluation performed in conjunction with the audit of the Pension Benefit Guaranty Corporation (PBGC) FY 2014 financial statements.

During the financial statement audit, we assessed the PBGC information security infrastructure for technical weaknesses in PBGC's computer systems that may allow employees or outsiders to cause harm to, and/or impact, PBGC's business processes and information. We found the culture surrounding vulnerability management has improved. PBGC's information security critical and high vulnerabilities have decreased and patch management has achieved the highest level of maturity in the agency's history. At the same time, PBGC continues to have challenges in mitigating longstanding weaknesses, as a number of issues have continued for multiple years.

Due to the sensitive nature of this report, its disclosure has been restricted. The final transmittal memorandum will be posted to the OIG external website, but the attachment summarizing our evaluation will be redacted in its entirety because it contains privileged and confidential information that, if disclosed, would cause further vulnerability.

This work was conducted by independent public accountant, CliftonLarsonAllen LLP. We appreciate the cooperation that CliftonLarsonAllen and the OIG received while performing the testing.
